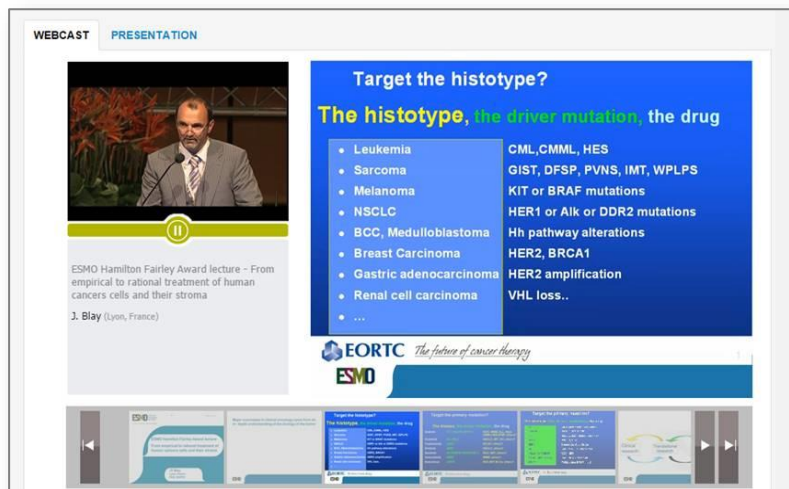


CTI's "WEBCAST ON DEMAND"

Using CTI's cSlide onsite presentation management system, session room lectures and presentations are captured digitally using the presenter station laptop. Your choice of output formats is automatically generated to ensure the content online can be displayed online consistent with your society's content curation goals and technology.

What you get

- The presenter's voice and video are synchronized with the presentation resource material (typically PPT slides)
- Content collection (recording) is handled through the presenter station laptop so that all animations, videos, and cursor movements are captured in real-time
- Presentation slides are indexed, with thumbnails generated and available for easy navigation
- All animations, videos, and cursor movements captured during the live session are shown upon replay
- Audio version can include the presenter's photo (or logo)
- Postproduction is fast and fully-automated so that you can host your content as quickly as possible
- Final content is available online in the viewing format/s of your choice (audio and/or video streams)
- Content is optimized and available through all mediums (Mac, PC, mobile) and access methods (hyperlink, VOD, CD-DVD-USB, cView library)
